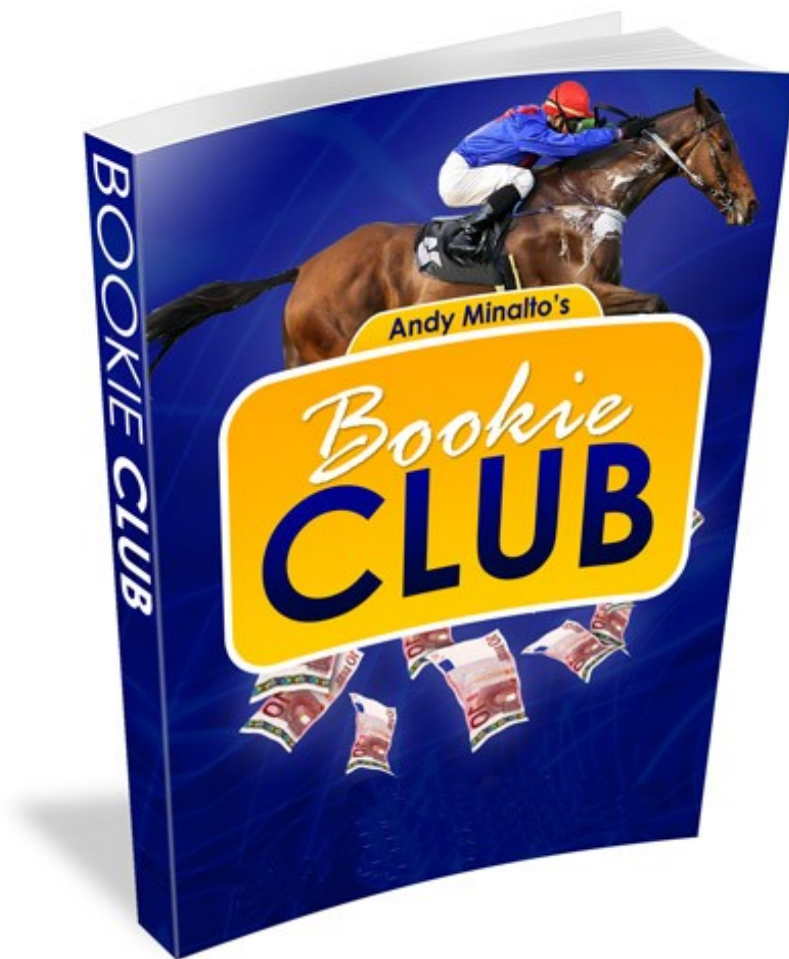


# **5 Stealth Secrets You MUST Know To Make A Full-Time Income From Online Betting!**



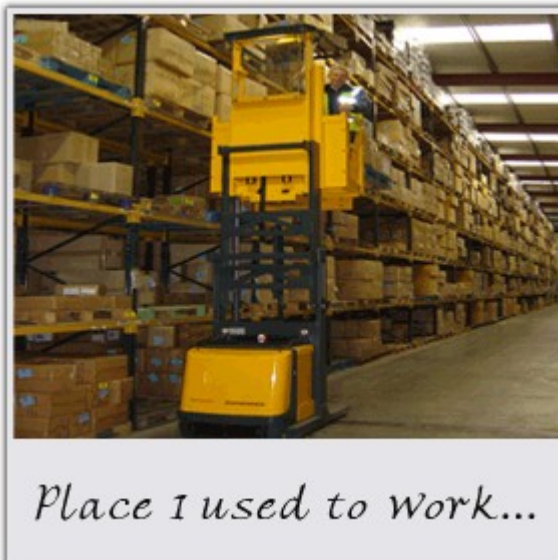

### 1. Gamblers Mindset

Before you even start to think about making money from online betting, you have to be sure that you're not a mug punter, gambling addicted person who needs some serious professional help.

If you feel that you don't control your betting activities and rely on wild luck to make money online, you seriously have to start different. There's much more into online betting than just try to predict a winning horse in a particular race. There are much more profitable systems than these. There are much more safer systems than these.

**A good question to ask yourself is: "Would you like to get £100 from a betting bank of £30 now or increase your betting bank by 1% every day?"**

Gamblers usually will choose first option but smart investors – second one. 1% daily grow from £30 seems very little, well, to be exact – it is 30 pence first day.

But do you know that by making just 1% daily, your £30 betting bank will turn into £537 in 1 years time? **Or £300 into more than £5 k?**

You have to start think in numbers – profit/loss, betting bank, ROI (return on investment) etc. It's really enough to make only 1% profit of your bank every day to become a full-time sports investor. Don't you think it shouldn't be possible? Just 1% per day? Just £1 from a bank of £100?

**It is more than a possible!!!**

Just forget about sport, forget about bad luck, forget about emotions and concentrate just on numbers. Be smart! **Make right decisions!**

How you think the richest people in the World managed to grow their wealth to billions dollars? By investing money. They're very happy for 30% return **PER YEAR**, because it turns 30 million dollars into 200 millions in less than 10 years time.

But you don't have to have millions to invest and you can make 1% per day, guaranteed profit, without any risks if you use some online betting loopholes.

Have you ever talked with any real gambler? I have. I had a friend in Newbridge (small town 30 miles out of Dublin). **WOW – That's What I Call GAMBLER!** He was alcoholic as well but that doesn't matter.

Every time I met him, he talked about how last week he won 500 EUR placing bet on "Arsenal", how he won 300 EUR from 10 EUR in less than 2 hours by placing bets on dogs etc.

But he never ever mentioned loses... NEVER! He always talked about winnings. He didn't have a betting bank, he didn't know how much he placed (most of the time simply because he was drunk), how much lost and won.

**But I know that he lost far more than won.** I personally knew his wife, and from time to time I had to listen horrified stories about she's life, how his husband is in 30 k debt and so on....

This is a real life example why bookies are still in business. And they're doing really good. Their profit margins are highest in comparing to any other industry – because 99% of betting public is pure gamblers.

Even when they win, they lose it all on the next bets. Bookies are laughing all the way down.

Why you think bookies can give you £50 free bet? Because **average player loses £200** before leaves bookmaker and goes to another. They play on the fact that most of the people are emotional, unprofessional and in many cases drunk.

And you don't need to go in debt or take second mortgage on your house. All you need is a £100 - £1000 bank and a 1% daily profit. **Never ever borrow money for your betting activities!**

It's o.k. To place a tenner on Sundays soccer game to make it more enjoyable by watching on TV. There is nothing wrong with that if you take betting as a entertainment. But if you want to make steady profits month after month, it simply won't work.

### So to recoup:

- **Start look into numbers** – all you need is a 1% per day to quit your day job and start make full-time living from online betting
- **Don't gamble** but invest for guaranteed profit
- **Forget about emotions**
- **Look around you** – don't make the same mistakes as others do by wasting their time on studying form to pick up a winning horse. Use profitable, easy to use system to invest money for guaranteed returns rather than place a lucky bets on pay day.
- **Play smart** – not hard!

### 2. Betting Systems

So now you now that it only takes 1% daily profit to make full-time income from online betting. So how to make it happen? Which system to use? Aren't all betting systems scams?

**No, not all betting systems are scams.** Most of them simply don't work! :-) At least in long term. To better understand what types of betting systems are out there and my personal experience with them, read on:

#### Smart Statisticians

*\*Betting guides, systems, and software that try to predict future sports scores based on scores in the past.*

These kinds of systems were among the first that I bought... and they were also the biggest money wasters in my experience!

These betting systems sound great in theory, but if you're anything like me, you don't want to immerse yourself in theories of probability and statistics... (I studied these subjects in university -- boring!)

... You want to ethically make as much money in as little time as possible with as little up front as possible!

To be blunt, sports scores in the past DON'T predict the future, and have very little correlation to sports scores that are to come.

PLUS, the return on investment with these betting systems is usually SO SMALL that you have to work twice as hard as you would if you used other techniques to make the same amount of money!

Did you know that even famous Brimardon Racing System ([Brimardon.co.uk](http://Brimardon.co.uk)) shows overall steady loss? And they charge several thousands £££ for yearly subscriptions!

Of course, they have to charge – otherwise how could they afford to place half page ads in Saturday's "Racing Post"? Don't be ridiculous – better send that money straight away to "Red Cross"! This way at least money is not wasted in the wind.

#### Tipsters

*\*Betting "gurus" that offer to sell you tips and betting advice by phone or email.*

You may have seen friendly TV ads in which supposed "betting gurus" offer to reveal their secrets -- for a big fat payment of course!

But you have to ask yourself... if these "high roller" tipsters are so good,

don't you think they'd make enough from their bets that they wouldn't have to go out selling their tips to others?

In the beginning I was very enthusiastic about these services, but as I began to lose money using their tips and advice, I realized that they too rely on statistics for their betting strategies...

... What I now know is a MASSIVE mistake!

I spent several THOUSAND pounds on roughly 10 pieces of worthless advice from tipsters before I realized these guys are all pirates out to make a quick buck at my expense.

**The fact is this: NO tipster service can possibly ensure you a STABLE, long-term income.** Better to just give your money away to charity than to these folks!

Have you ever heard about Henry Rix? ([HenryRix.com](http://HenryRix.com)) He is one of the most famous tipsters in UK. He charges annual fee of £ 1499 for his "advice". Well, I'm not that stupid to pay so much for a one sms per day.

What I did – I joined tipster pirate service (tips relay) for a £30 per month to get access to more than 30 tipster services. Guess what? Henry Rix showed negative balance for the last 10 months. **EASY :-)**

### Progressive Betting Systems

*\*Systems based on accepting that you'll sustain some wins and losses, but you should come out "on top" over all.*

Out of all of the betting systems on the market today, this is the one that MOST people fall prey to and fork their dollars over for.

In theory, these systems seem to make sense... and the fact that they advertise you have an unlimited betting bank is very enticing!

But in reality, these systems only catch you in a cycle of constantly trying to make back any money you've lost... by betting more and more.

... And before you know it, you'll find yourself in a quicksand of losses and debt that you can't get out of!

To give you the straight truth, these systems are really nothing but high-risk gambling. Because they all are too risky in long term.

However I have developed very unique, low-risk progressive system by following which you can make steady 20% - 30% profit month after month (exactly what you need – 1% per day). It's called [Bet-Invest](#).

The best part is that you don't gamble with your money but invest for long term profits AND without taking any unnecessary risks. Yeah, you won't be doubling your betting bank every week, but you won't be under risk to lose it as well. Check out more about [Bet-Invest system here](#).

### Arbitrage Systems

You can find those type of e-books all around the web. They all will tell you the same: open dozens of bookmaker accounts, have a £10 k betting bank ready, subscribe to arb services (for a fair fee of course) and just wait for big money to roll in.

#### **To put it simple – are you loosing your mind?**

By following this traditional arbitrage betting system you have to open dozens of bookmaker accounts, pay monthly subscription fees for arbing alerts (these services will constantly scan all bookmaker websites to find any price differences) and have a moderate size betting bank to invest. Also many bookmakers could just refuse your bets if they find out what you're doing or even worst – cancel them after bets are already matched.

Arbitrage betting can be very profitable if you know what you're doing but please – forget about classical arbitrage betting system approach! There are more profitable arbitrage opportunities out there than these high-risk schemes.

### Lay Systems

*\*Betting on something that "won't" win -- so if you "lay" a horse and the horse loses the race, you win.*

When I first ordered these systems, I remember how excited I was at the beginning to make my millions (as I was promised when I bought them)...

But again, with lay betting you are really just playing the odds. Despite what these systems will tell you, you can't rely on past statistics to predict what will happen in the future -- in a horse race for example...

The thing is "Lay Bet" is the same old "Back Bet" - just reversed. So there is no difference in finding losers or winners. If you can find a loser, you can find a winner

So if you're looking for small, short-term rewards and a lot of stress, pick up one of these systems. But if you're looking for steady, regular gains, keep reading!

### Other Systems

Of course, there are other types of systems available on The Internet but the principles stay the same – 99% of them are too risky to make steady income without stressing all day long.

One of the different group of systems is about **Betfair Trading**. They're not about how to select winners or losers but how to make profitable trades on Betfair. Most popular subjects:

- **Soccer Trading** (mostly in-play techniques)
- **Tennis trading** (mostly in-play techniques)
- **Horse racing trading** (scalping, strategical techniques)
- **Rugby trading** (mostly in-play techniques)
- **General sports** (Wight of Money techniques etc.)

Here's a few of my betfair trading books I bought in the last couple of years:



Betfair Trading is a very interesting topic and there are some very profitable techniques to make nice amounts of money from relatively small betting bank. I do trade myself and you can read more about several trading techniques and watch some videos on my [blog](#) and [website](#).

### 3. Software and Tools

In order to make money from different betting systems, you'll need some sort of specific software. For example, nowadays you can't become a professional betfair trader without a proper trading workstation. Or you can't use a progressive betting system without a specific software or at least Excel spreadsheet.

Just for you to know – I have tested **LOUDS of betting software** and can honestly give my objective reviews on what works and what doesn't work.

### **Betfair Trading**

You can't show good results on Betfair trading (unless you're placing strategical bets) without using a proper software. I have tested most of the popular services, like:

- **Bet Angel**
- **Bet IE**
- **Market Feeder Pro etc.**

They all have a range of good options and trading tools but they all very useless simply because they were unstable. They worked very slow (I have a very powerful dual-processor PC and 5 MB/s broadband internet connection), very commonly they just "freeze" in the middle of trade. And basically they all are too complicated tools.

My all time favorite trading software is [Bet Trader Pro](#). It's simple to use, yet so powerful, fast and affordable. You can even get 200 Free minutes trial just by signing up. I strongly recommend to use [Bet Trader Pro](#) for all your trading needs.

If you're looking for free solution, [Bet Angel Basic](#) is a good option. There isn't much trading tools available but at least you'll be able to place "one click trades" with ease.

[Bet Angel Basic](#) is a good solution for arbitrage trading as well.

### **Progressive System Software**

There are many progressive betting systems available on the Internet. Most of them will give you a free software as well. Prices range from £20 to £97 – basically they all are the same, just wrapped in different packaging. Some of the most popular:

- **Ultimate Betting System**
- **Dreamcatcher**
- **Sure 2 Profit**

If you need just software, you don't have to spend £££ to get one. You can create it yourself using Microsoft Excel. Formulas are a bit complicated but you can work it out.

### Arbitrage Software

Arbitrage software is an essential tool to make steady profit from arbitrage betting. **Or isn't?** Obviously if you want to follow traditional arbitrage systems and look for miss priced odds over several hundred bookmakers, you can't do it without arbitrage software.

**There are 2 types of arbitrage software:**

**1) Web based arbitrage software – service.** These websites usually charge monthly fee for accessing arbs they find by using complex software - data crawlers. Data crawlers are like Google spiders going through hundreds of online bookmaker pages and sends back to server prices for particular sporting events.

**2) Downloadable arbitrage software** – for a one time fee (or even for free!) you can get your very own arbitrage trading software. Some of the most popular solutions are "Sports Arbitrage Trader", "Sports Arbitrage Finder" and "Win Risk Free".

## 4. Money Management

As we talked earlier, you have to be very careful with how you manage your betting bank.

### **Rule Number 1**

Stick to the plan

### **Rule Number 2**

Always stick to the plan

### **Rule Number 3**

Don't forget to stick to the plan

**Sounds easy? Good!** But many people fail on this countless times in their lives – be it a betting, weight loss or quitting-smoking. You're in better position because you can change it right now by having a system, taking action and sticking to the plan!

When you get your profitable betting system, make a plan – write it down on a paper so you can see how much money you'll invest, what kind of ROI you're expecting and actual results. This way you'll always know how good or bad you're doing.

It's always a wise decision to allocate specific budget for your betting activities – this will be your betting investment portfolio. If you can afford only £100 that's o.k., If you have £1k – even better. Just remember -strating bank will not be a indicator of how successful you'll be but profit % you're making every day.

With £100 betting bank it will take just longer time to achieve financial freedom – but it will happen if you stick to the plan!

Never ever use credit cards, personal loans to fund your betting activities. Why? Simply because it's a first sign that **you're getting GREEDY!!!** Please don't! By doing this, you're gambling with your personal financial situation. We agreed that gambling aint make you feel good, didn't we?

### 5. Support & Coaching

In every venture in your life it's good if you can have a community around what you're doing. To be able to ask expert's advice, other people thoughts. Online betting is no different.

If you're new to online betting, you'll find out that it's very difficult to get unbiased system, software reviews or a personal support from someone who makes living out of online betting.

Good places to start with are betting forums. By joining betting forum you'll join a community where most of members face similar problems as you do. It's great to share ideas and get feedback on them.

When you're planning to purchase a betting system, software or a membership – make sure that seller is offering support and community where you'll be able to ask for a help, especially in the beginning when you could face some challenges.
